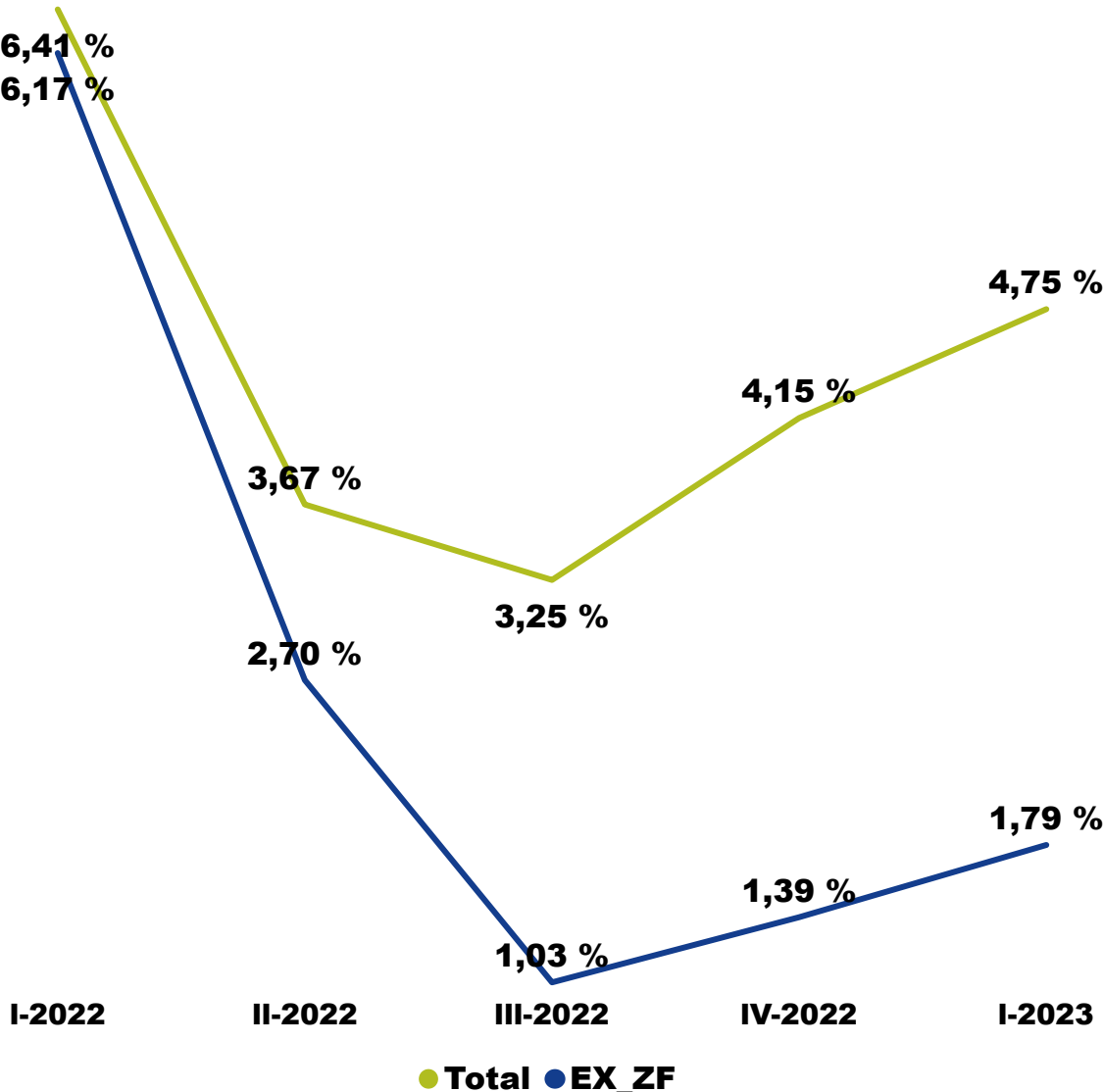




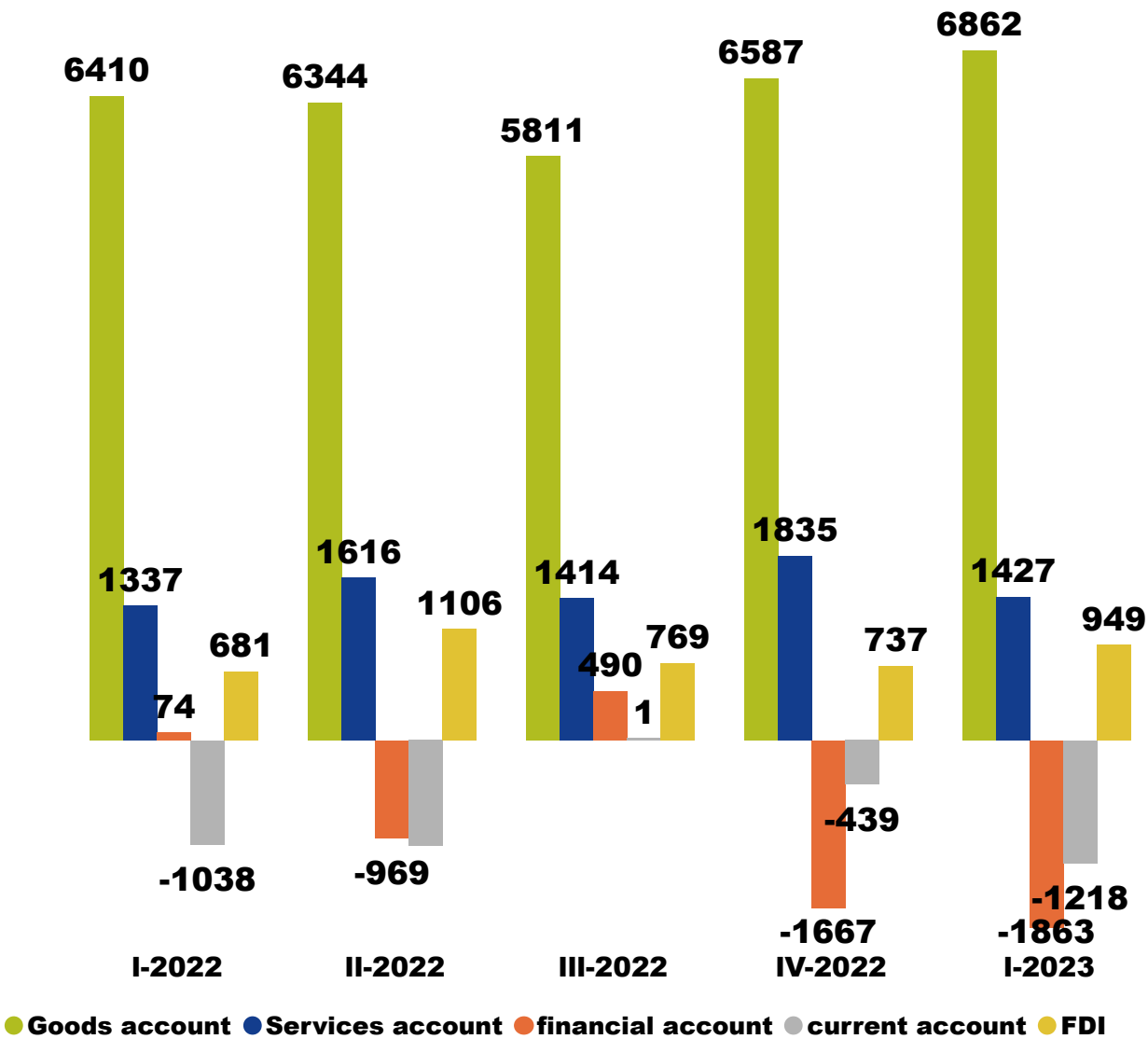

IMAE (YoY variation, %)



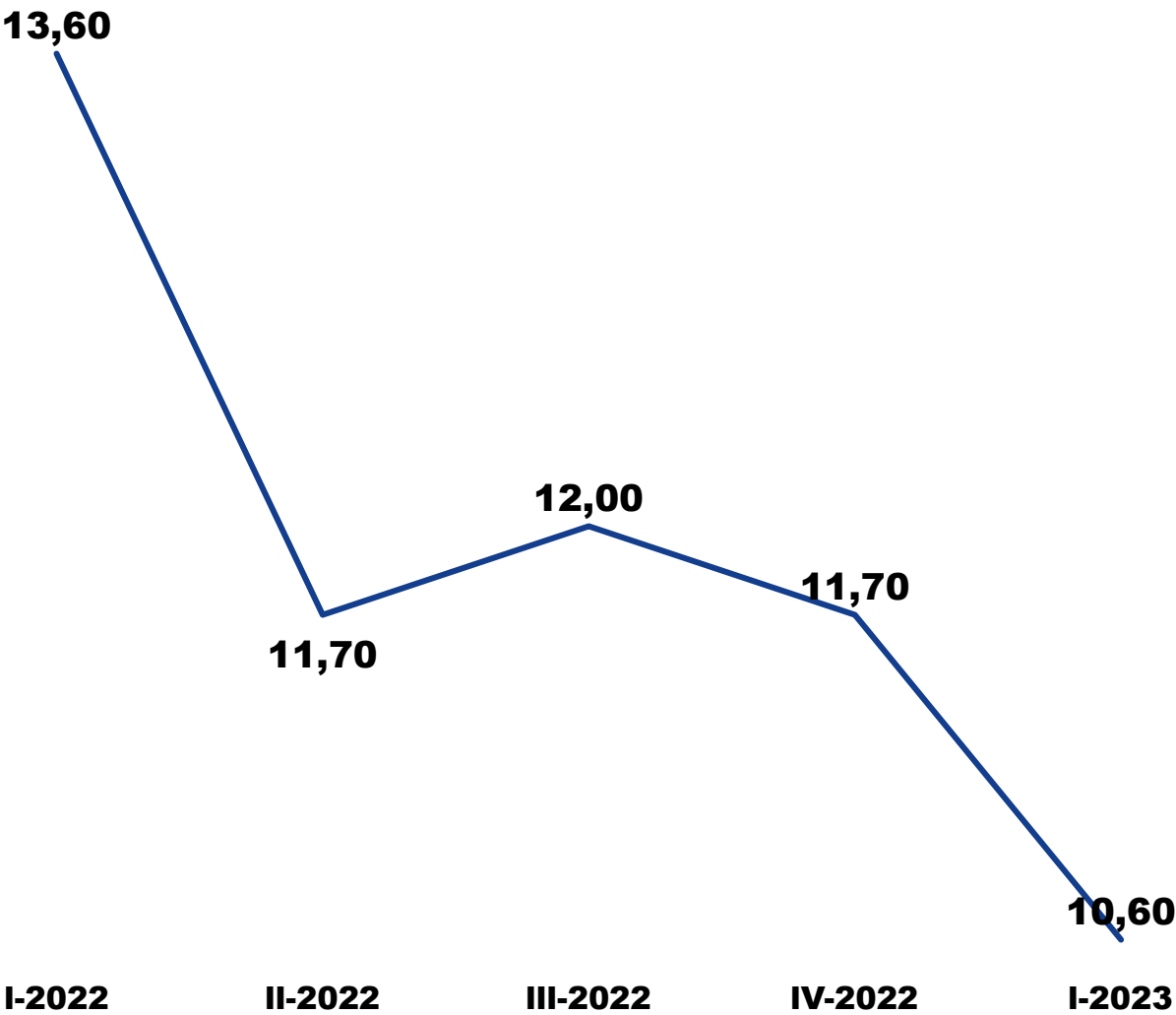
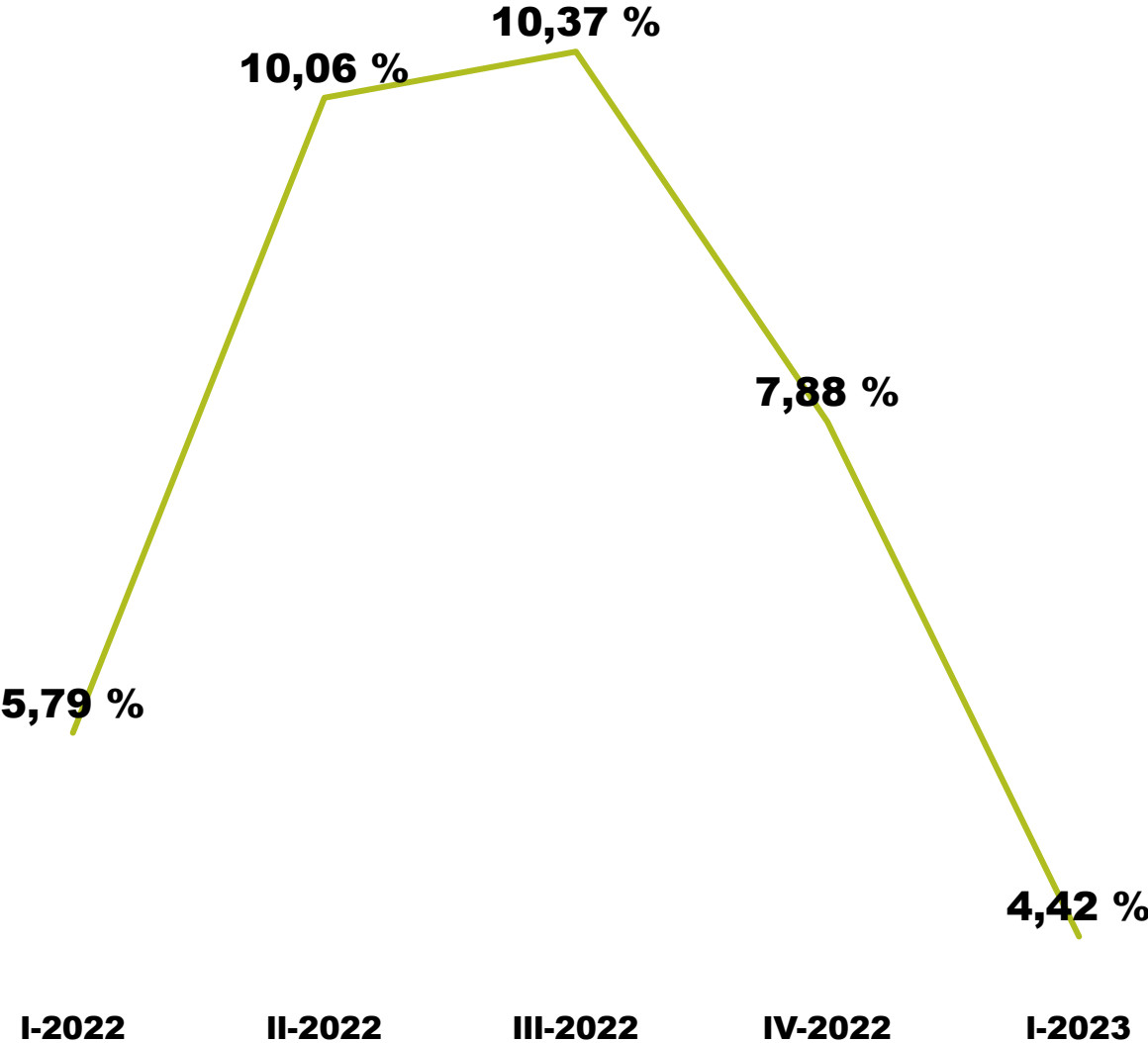
Balance of Payments (last year, million USD)

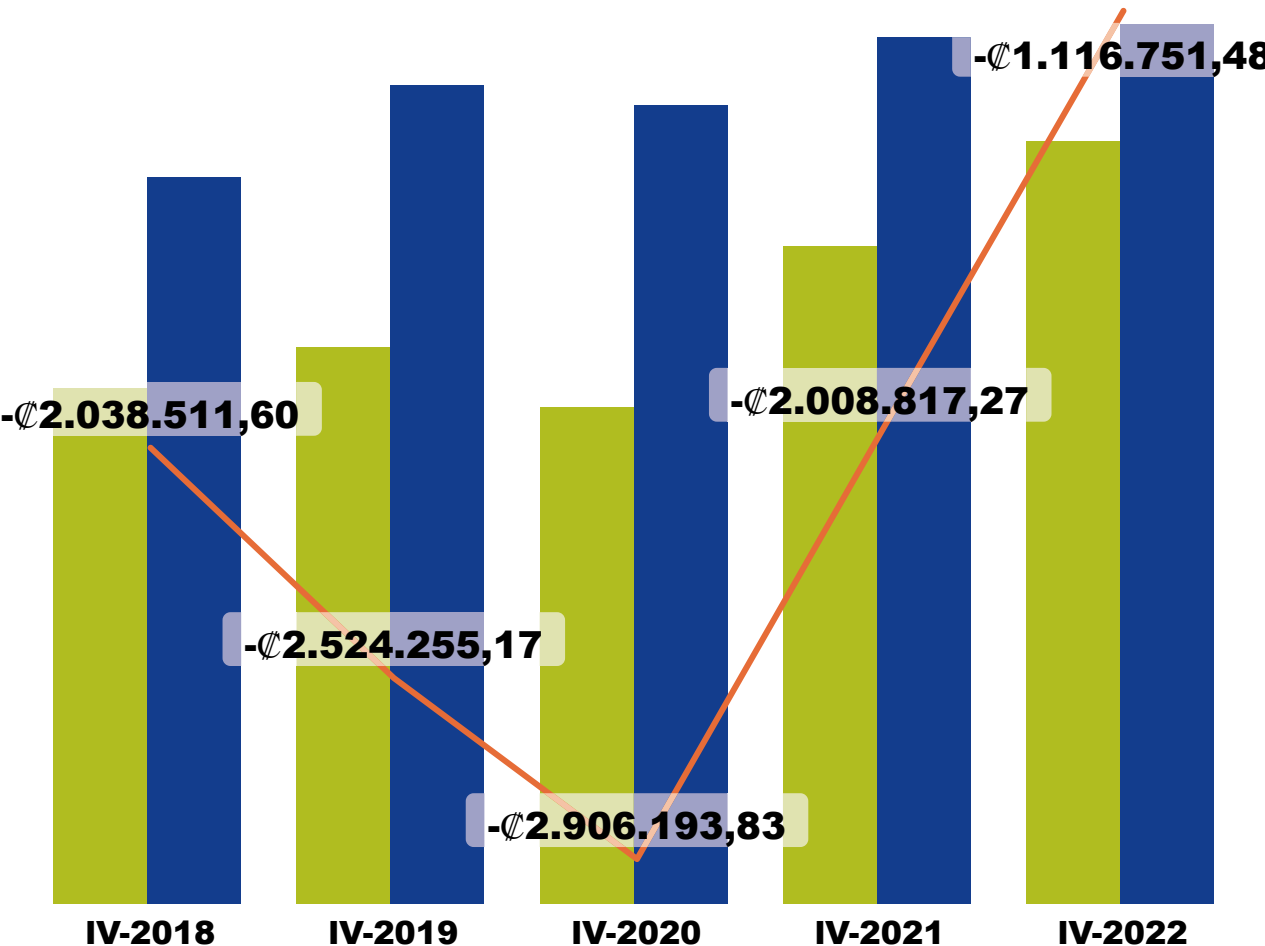

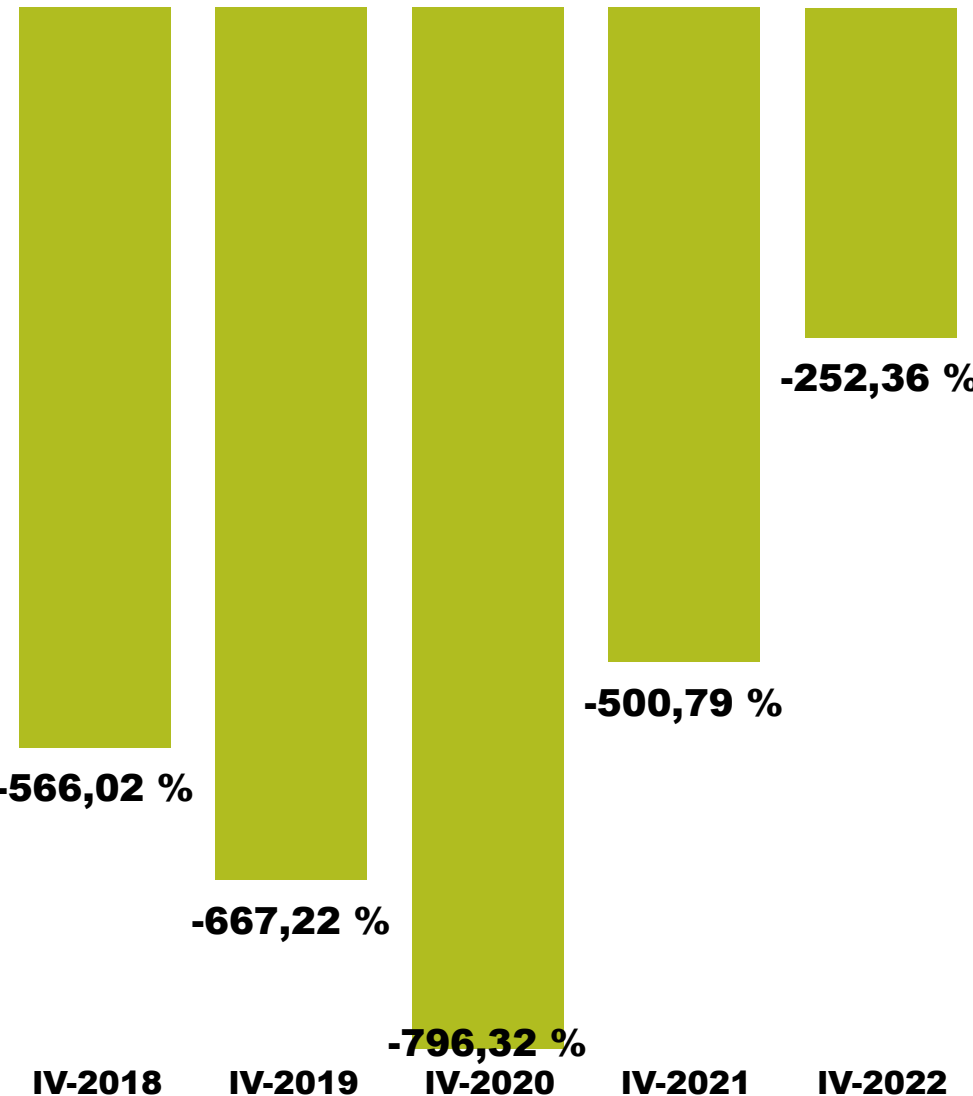

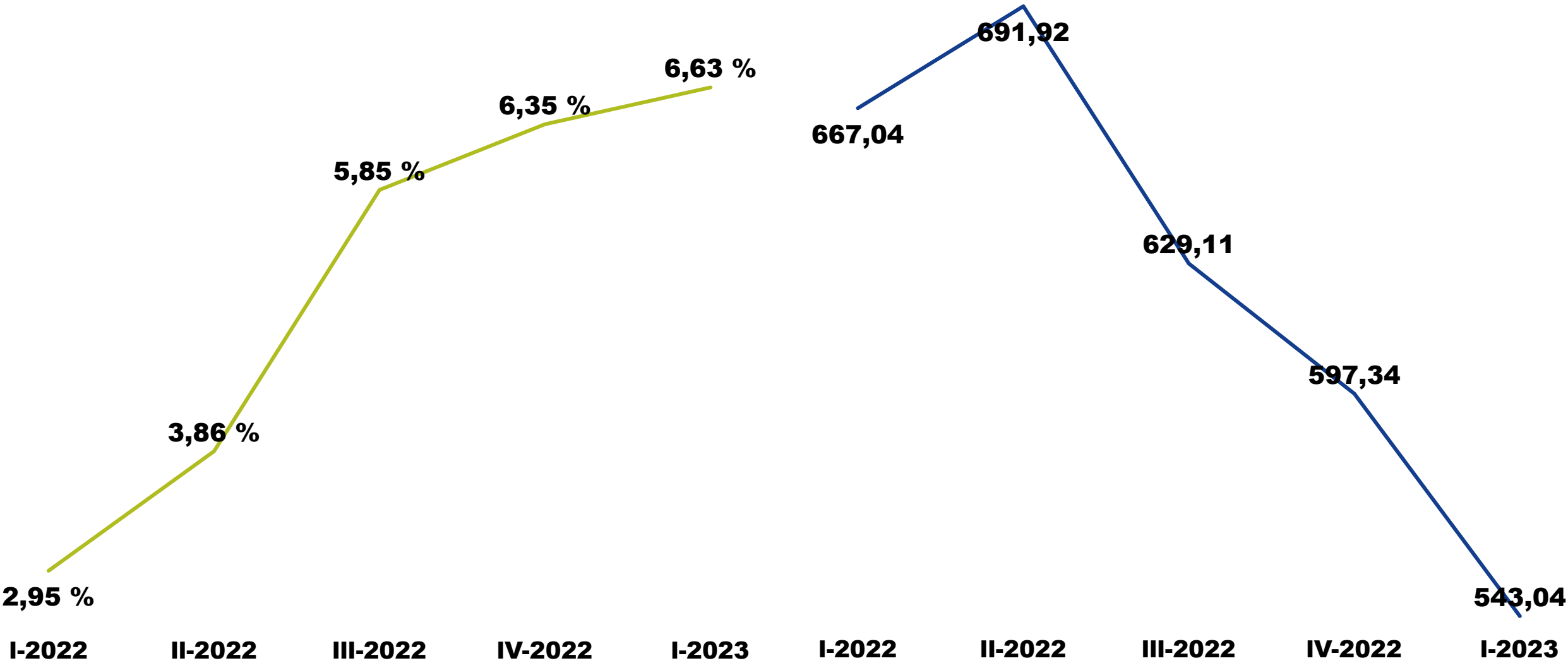
Central Government Deficit / GDP (%)

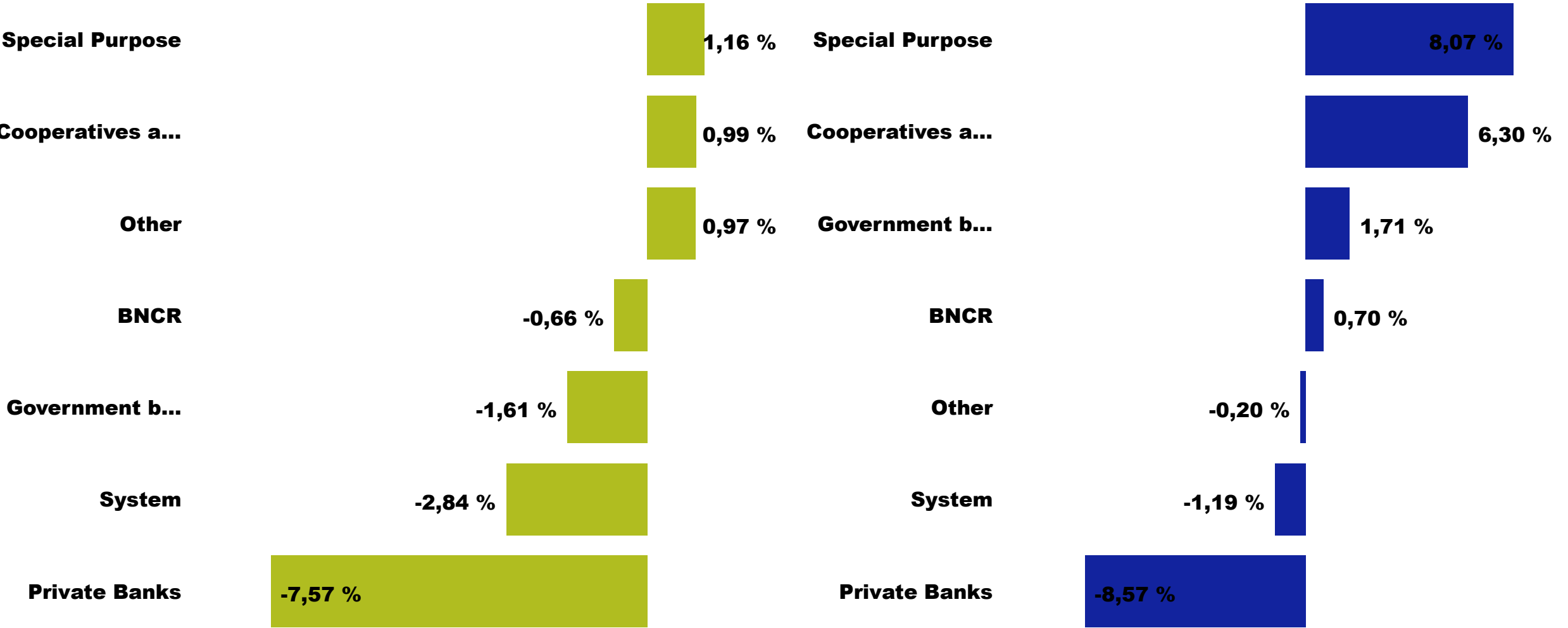

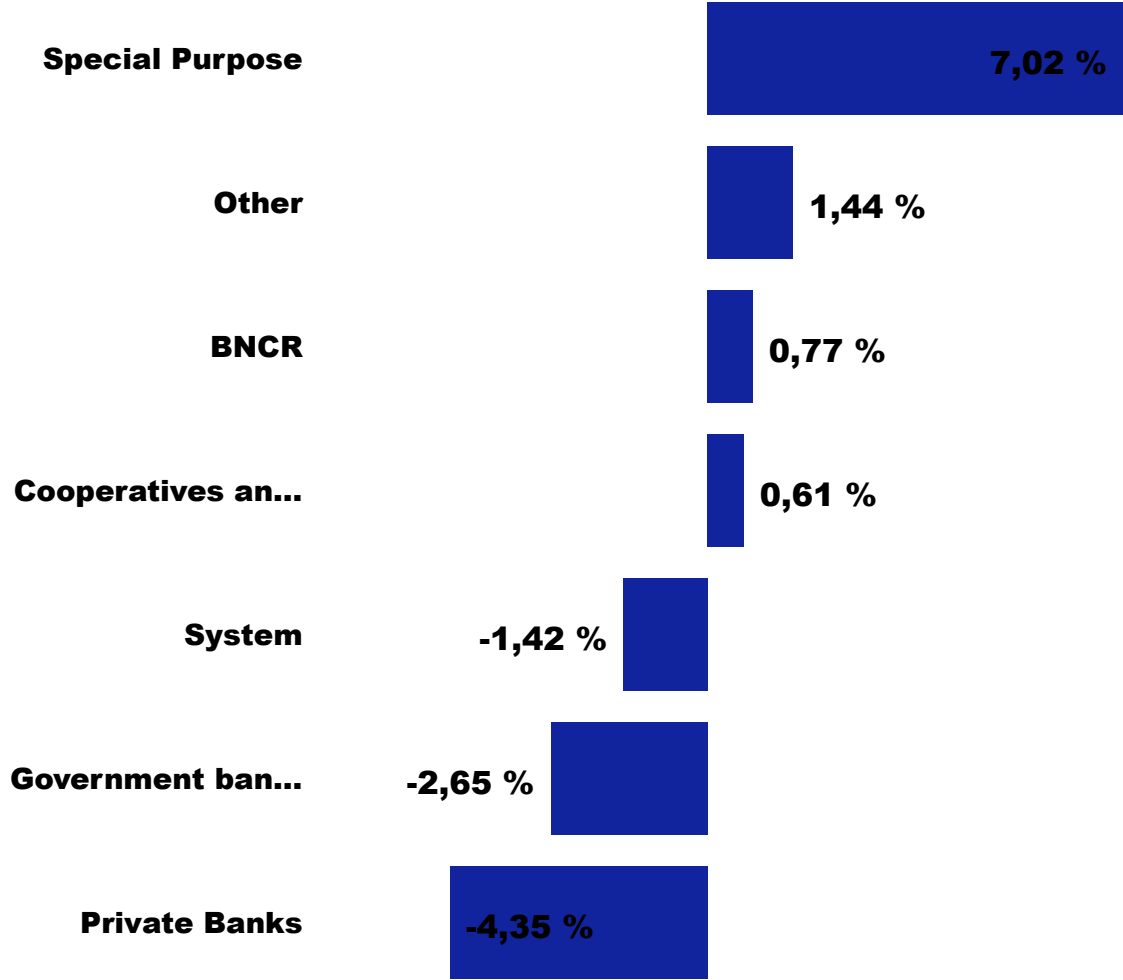

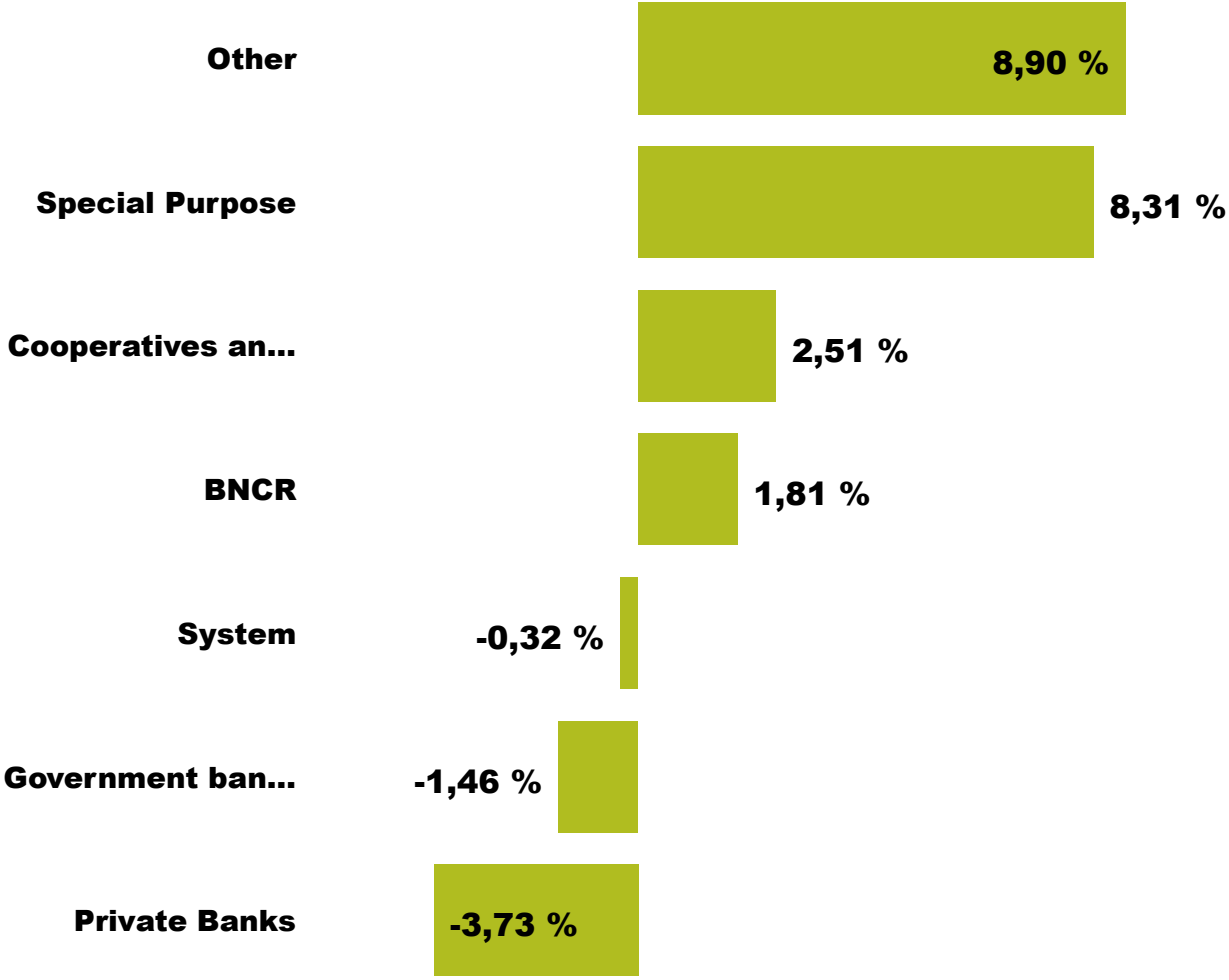

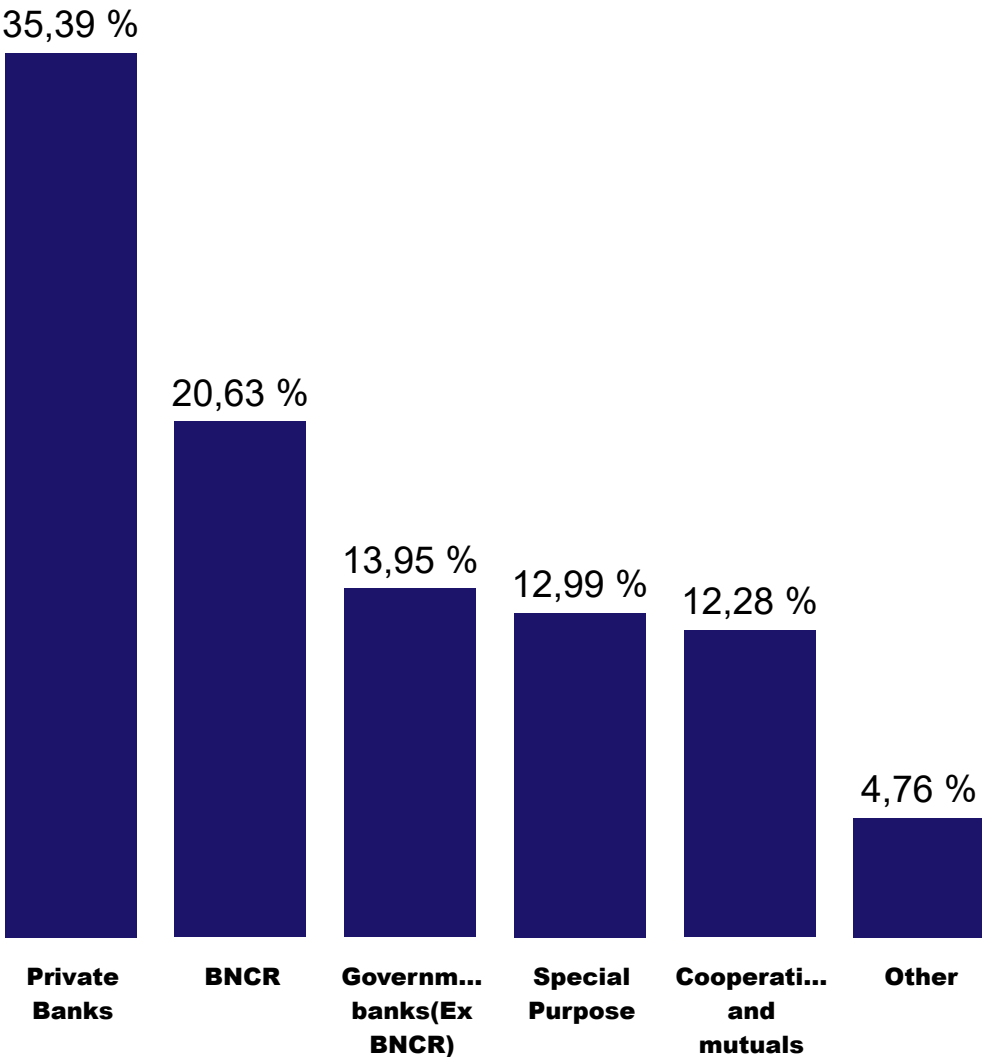

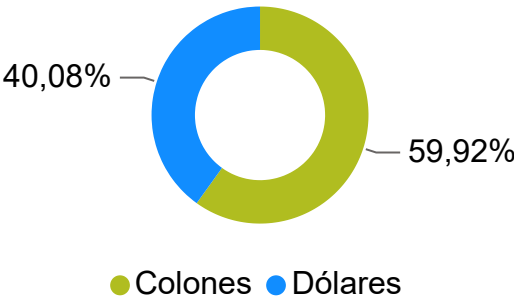

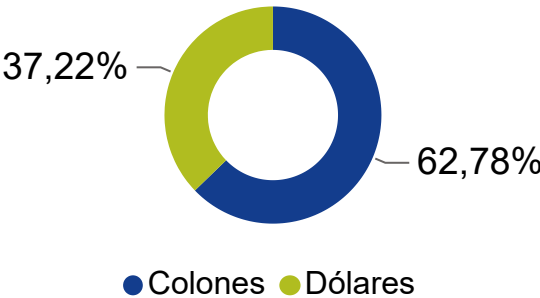

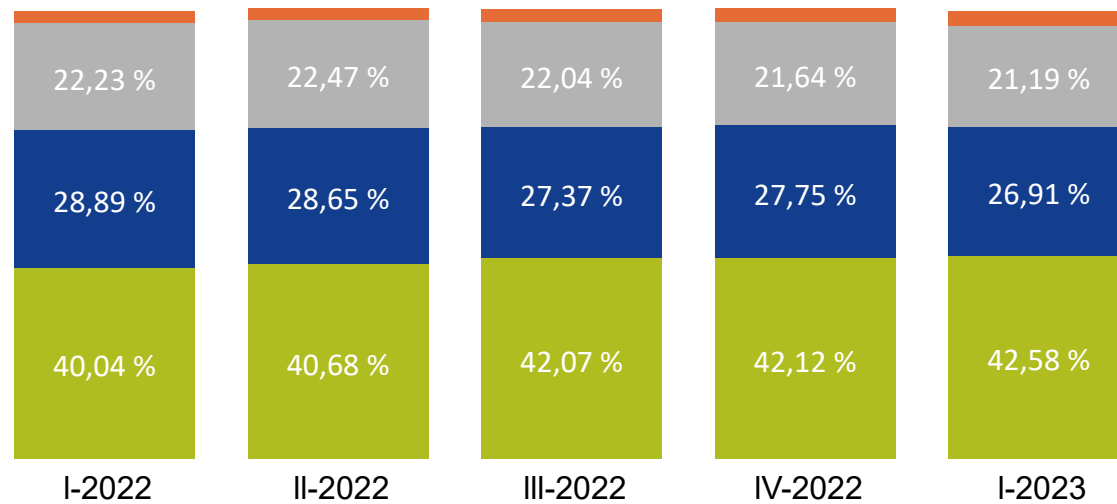

Loan portfolio gross (million CRC)

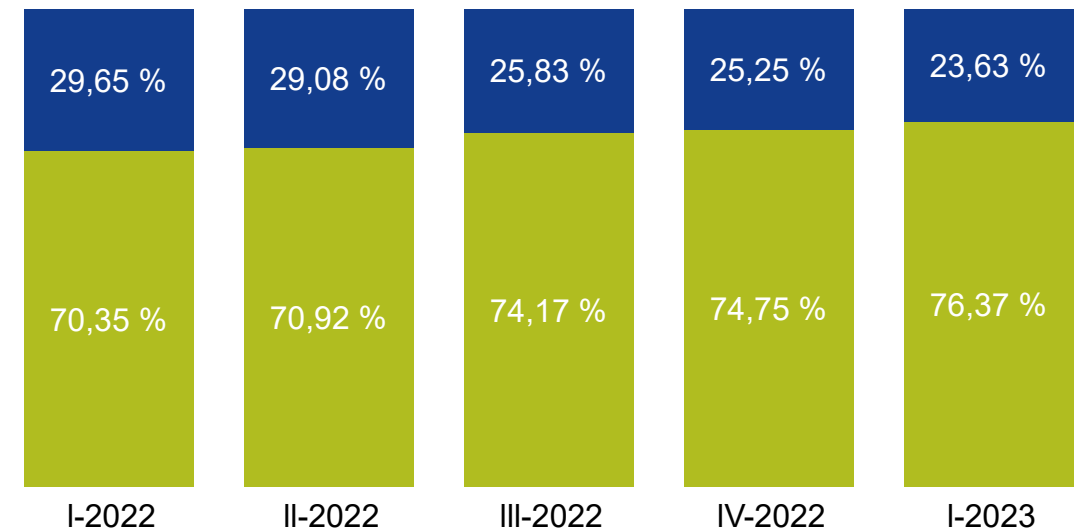


Portfolio composition (%)

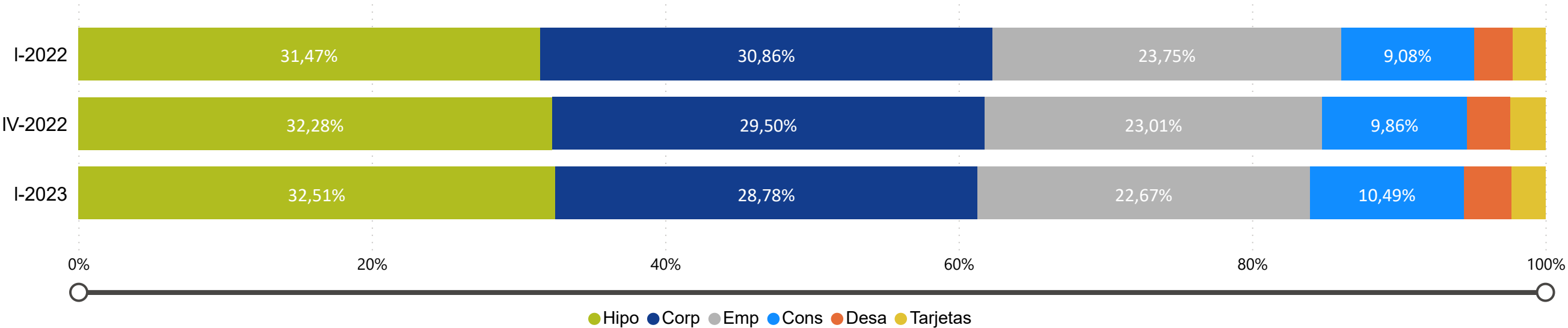
Loan portfolio by currency (%)

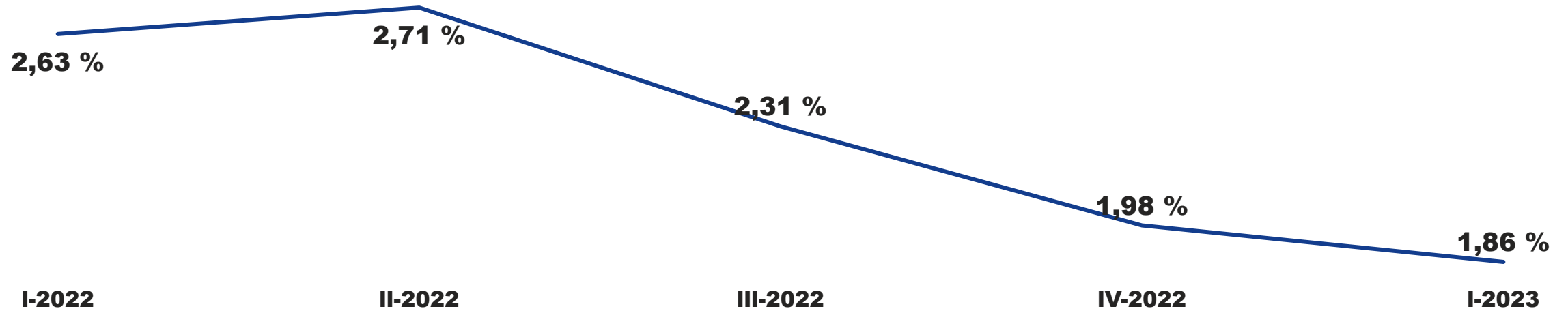

NPLs percentage of the loan portfolio (gross)



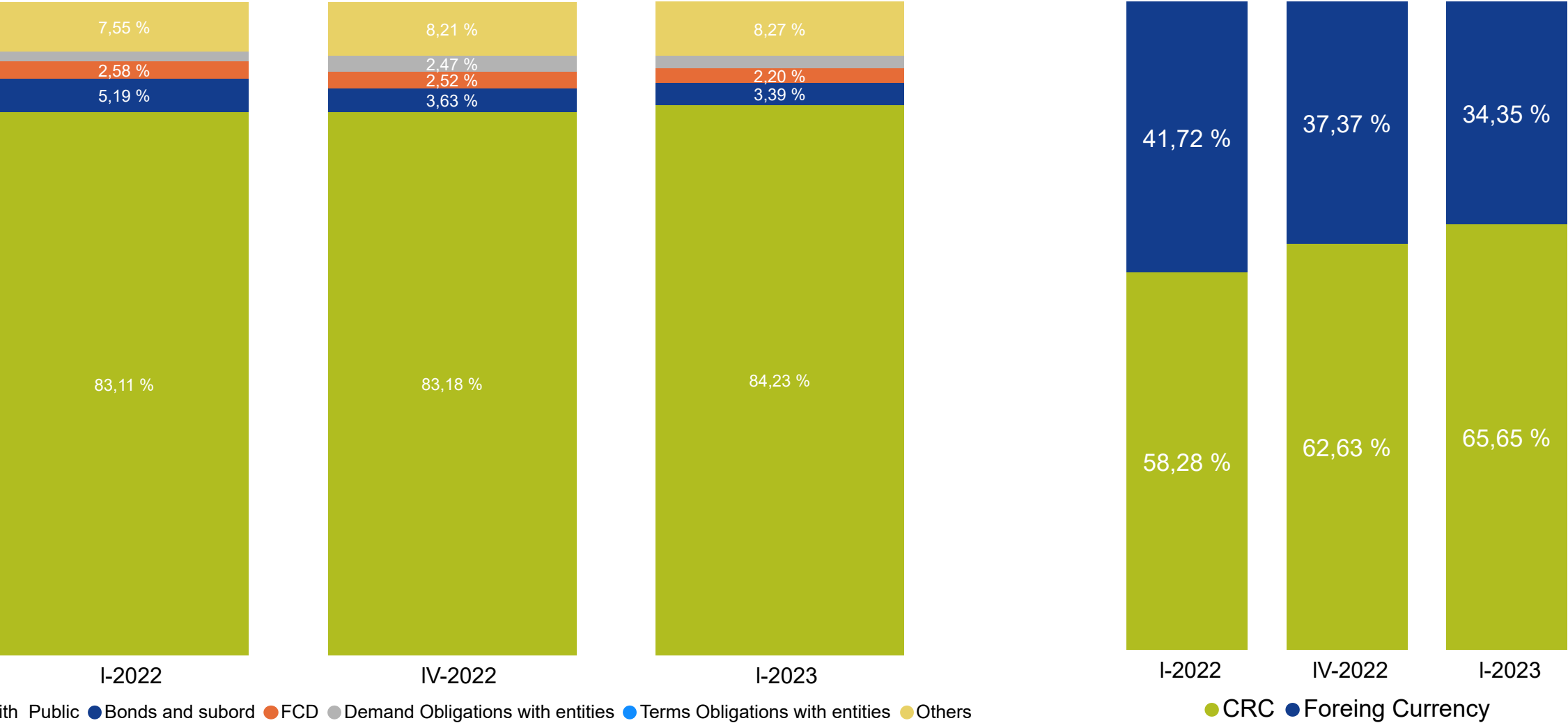

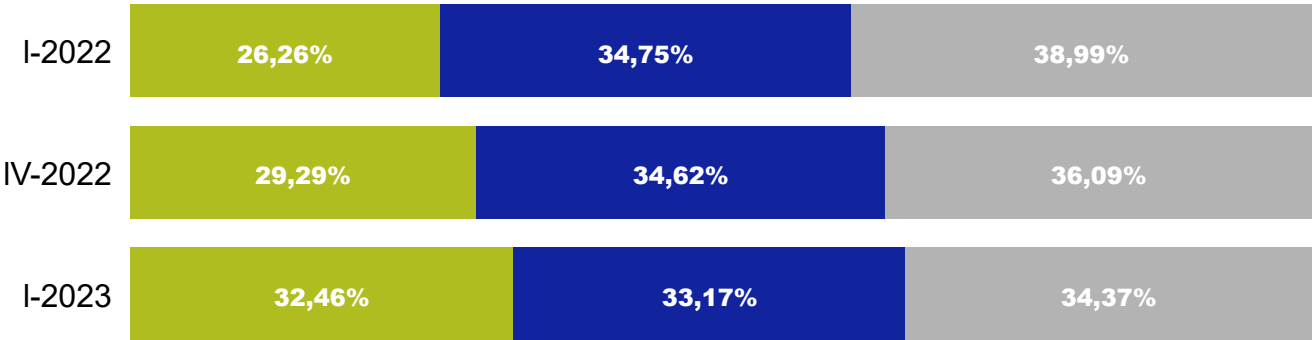

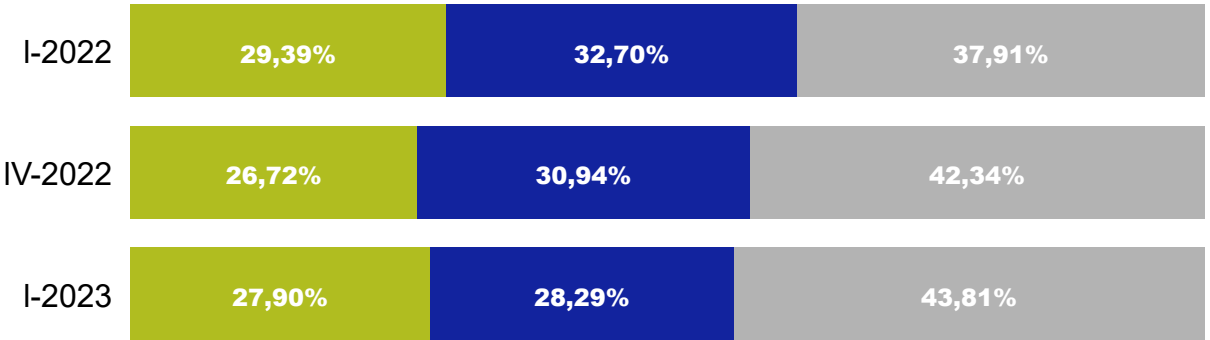

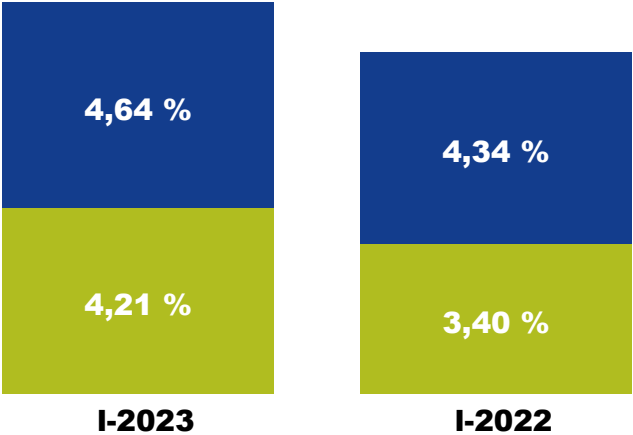

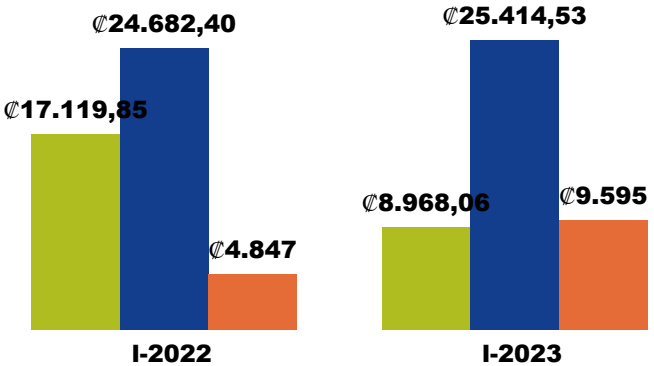

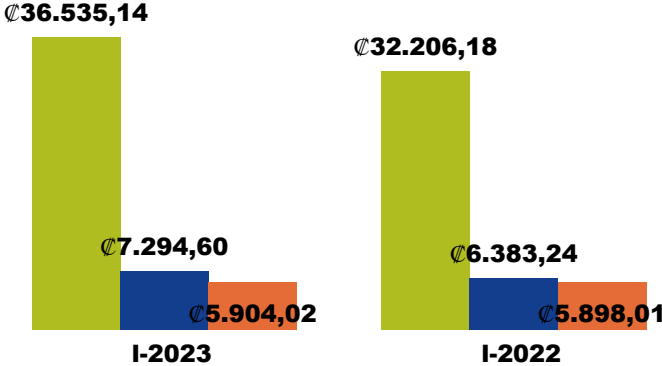

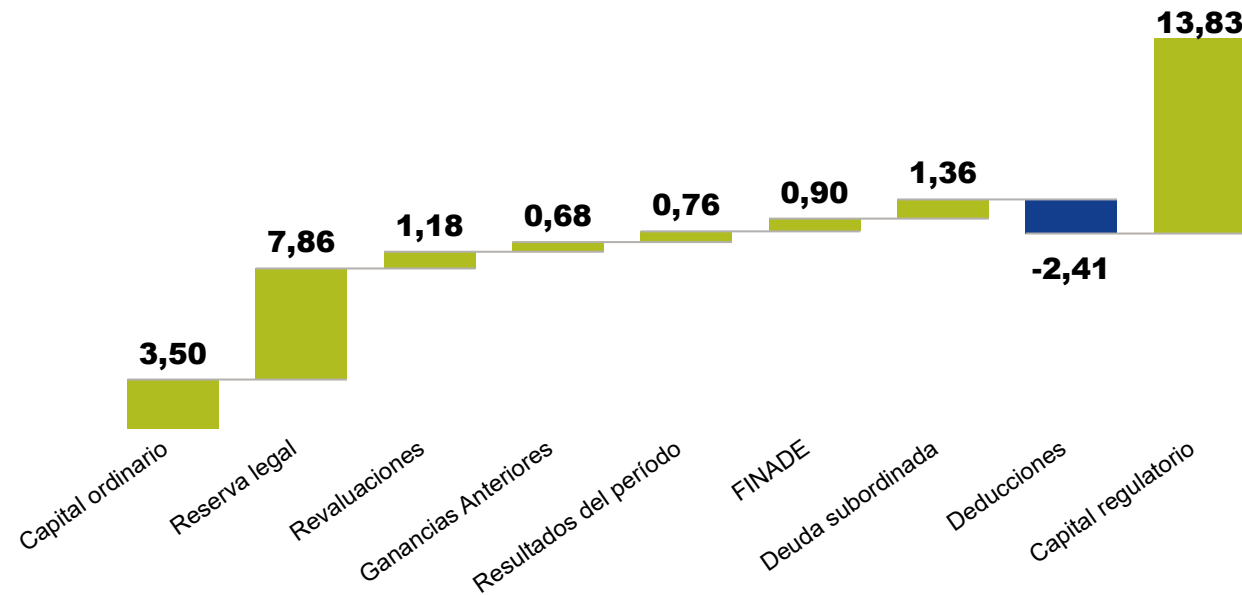

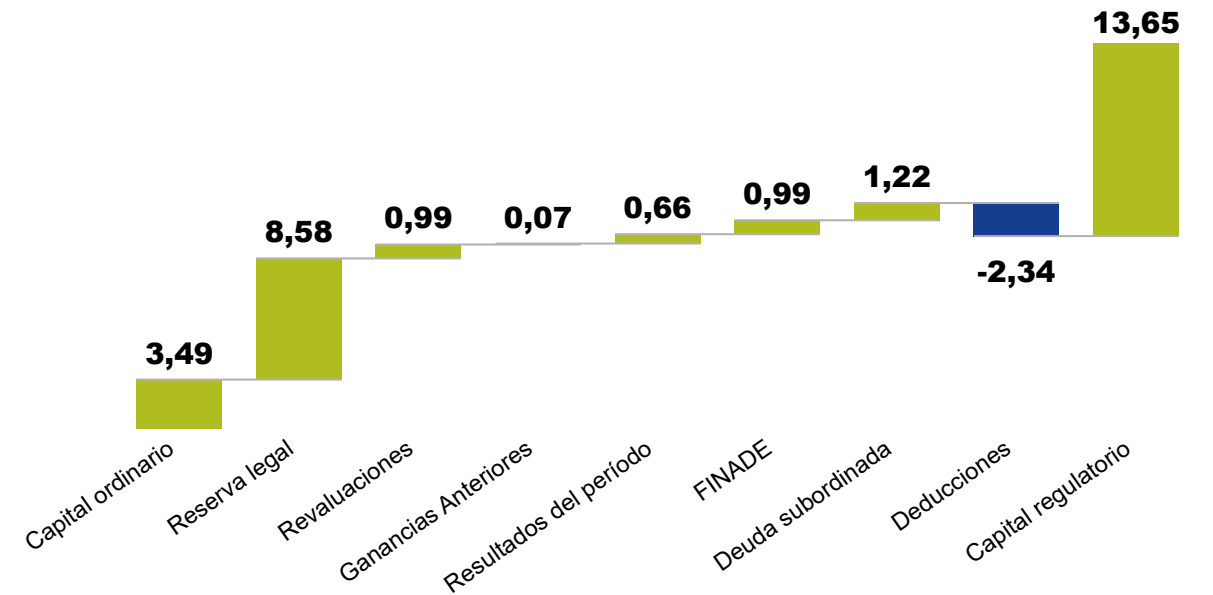

ISP composition (Dec-2022)

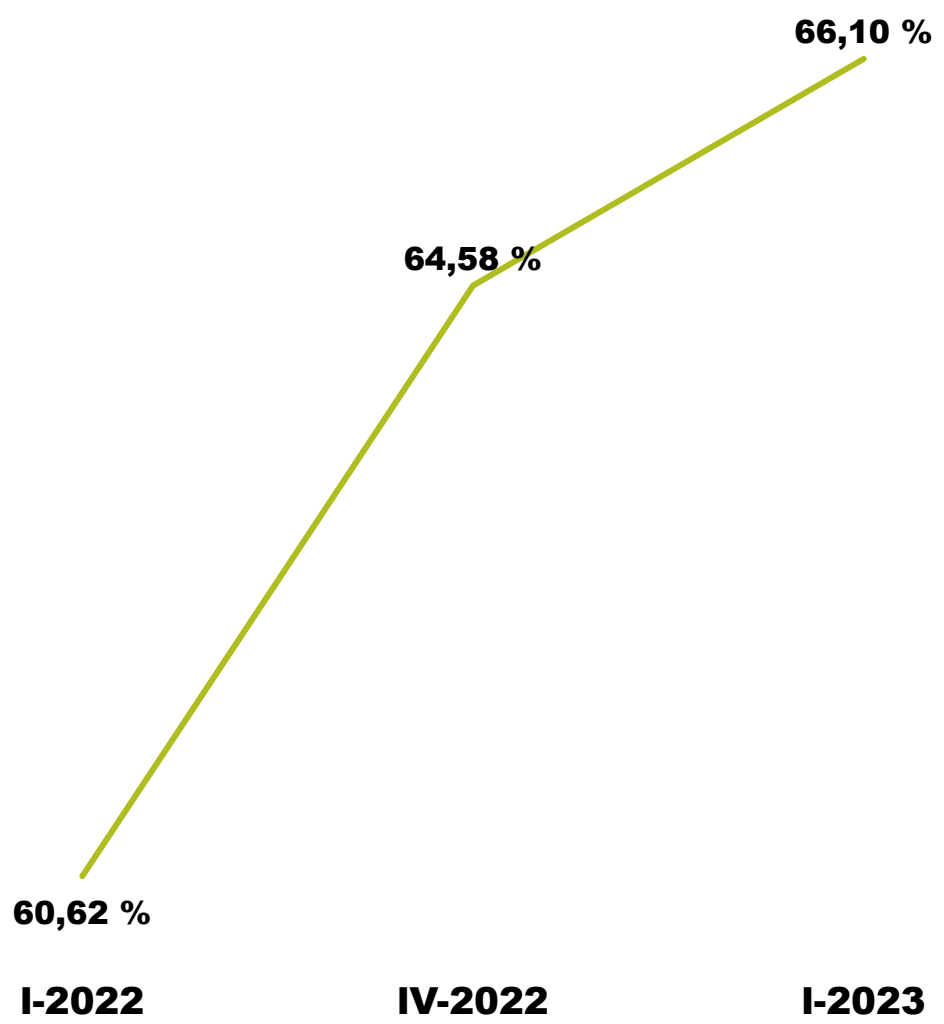

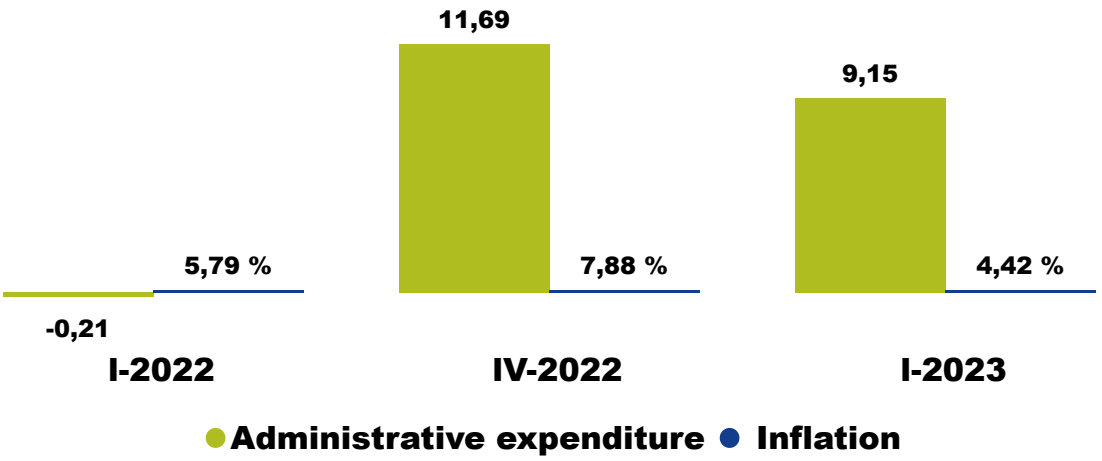

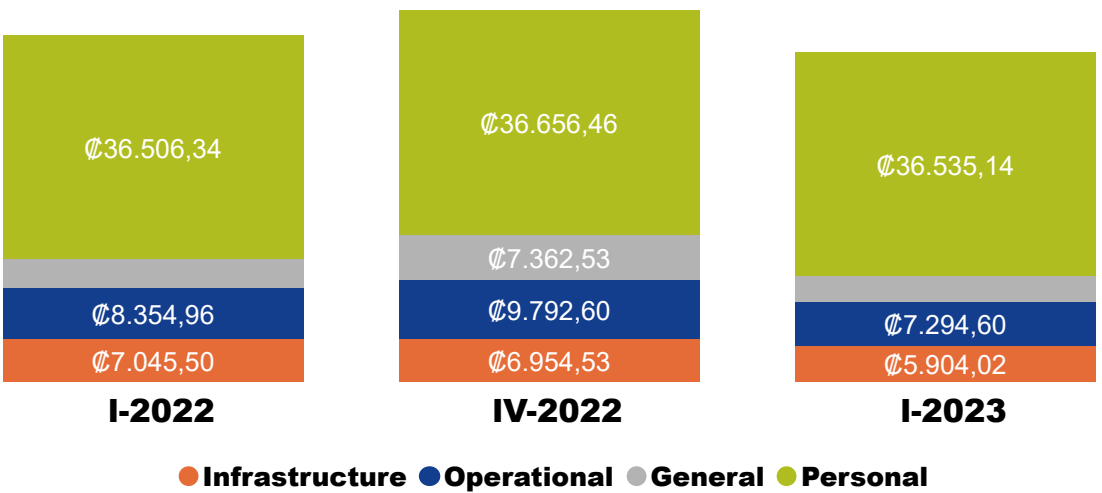

Administrative expenditure (YoY growth, %)

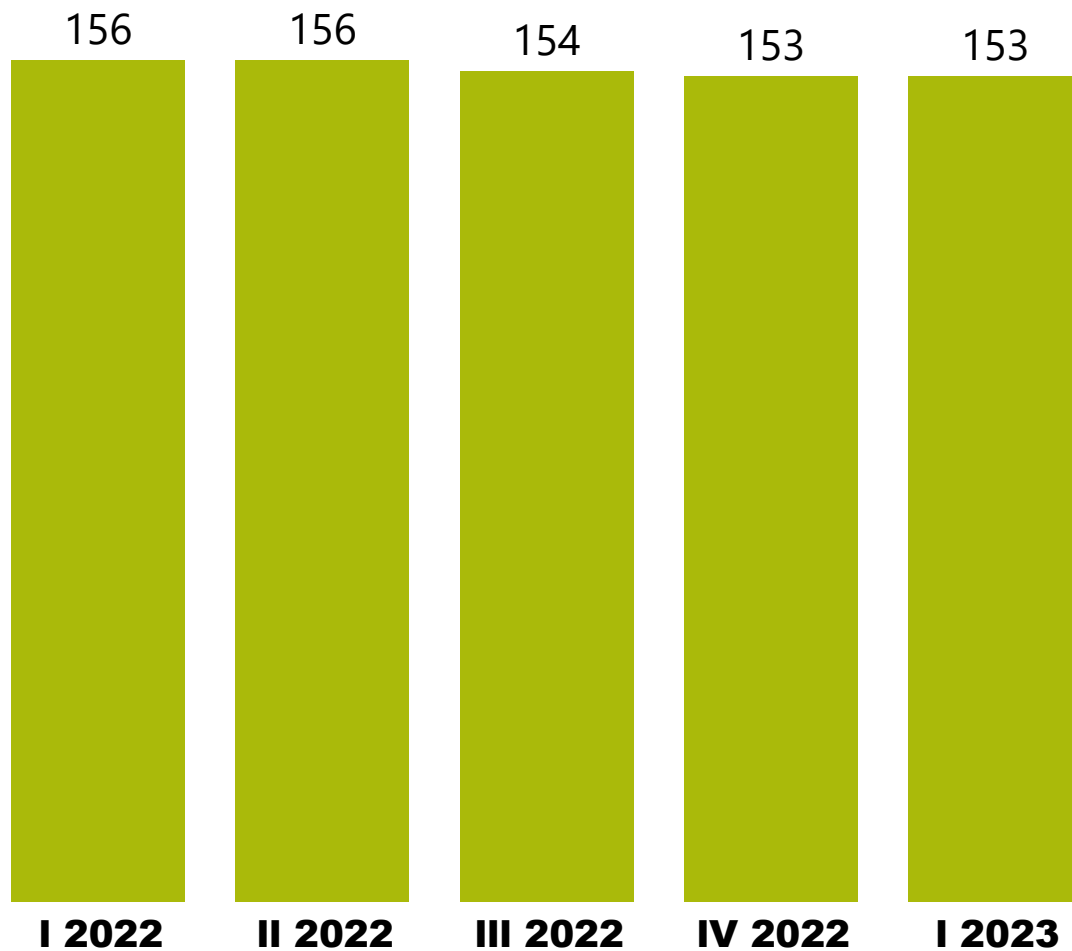


Administrative expenditure breakdown (million CRC)

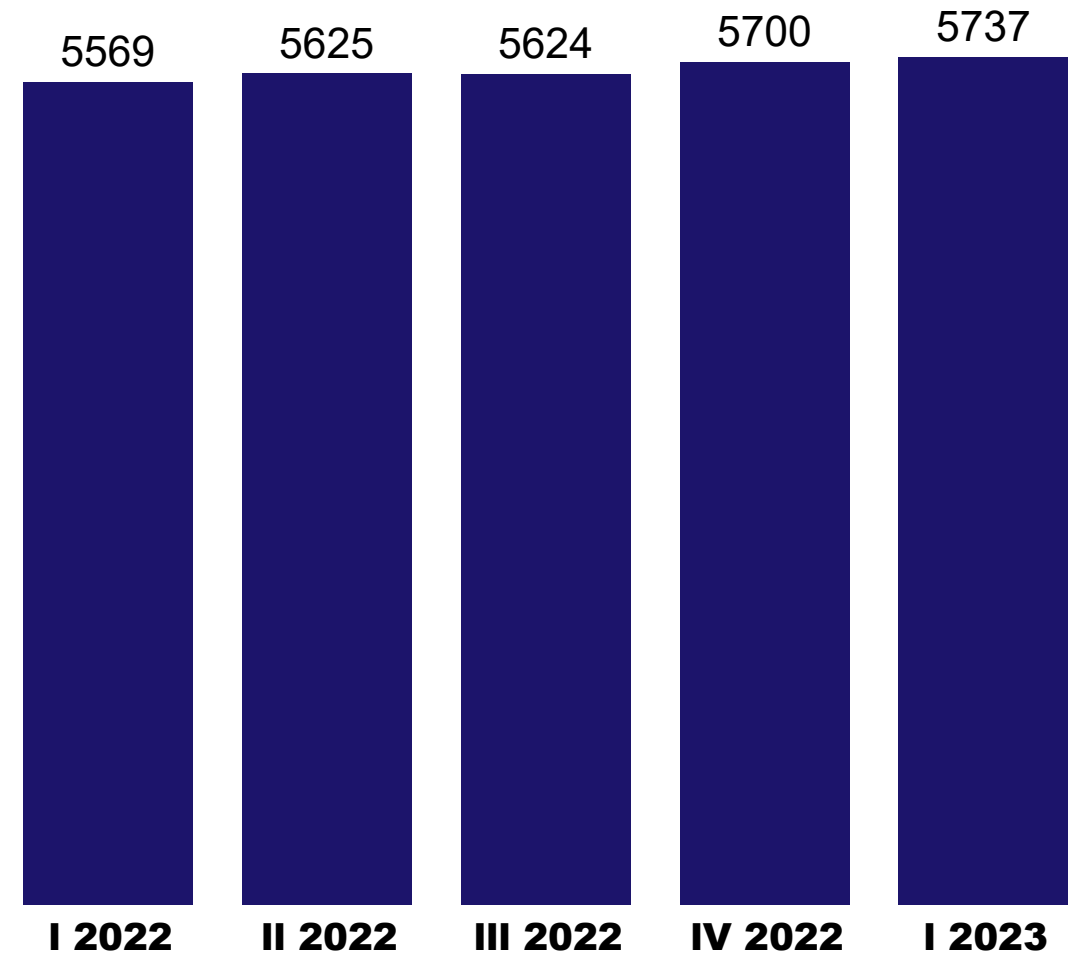
